Summary

The Snohomish County Rural Opioid Response Project Consortium is hosting community events in June to have conversations around stigma and substance use disorder. They are free and open to the public.

The consortium is a group of partners from organizations serving rural populations in Darrington and Sky Valley. The group formed as part of a grant-funded effort by the Snohomish County Health Department (then-District), which initially received funding in June 2019 from the Rural Communities Opioid Response Program Planning grant from the Health Resources and Services Administration (HRSA) of the U.S. Department of Health and Human Services. Between that round of funding for planning and a second, implementation grant, HRSA has provided \$1.2 million toward this work.

The overall goal is to reduce the morbidity and mortality associated with substance use disorder, and opioid use disorder in particular, in high-risk, rural communities across the United States. This is achieved through strengthening and expanding prevention, treatment, and recovery services to enhance rural residents' ability to access treatment and move toward recovery.

The consortium completed a gaps analysis and is working on the priorities they identified, including:

- early intervention and prevention
- reducing community impacts of substance use disorder
- increasing availability of treatment options
- eliminating barriers to treatment and support
- increasing education and awareness about substance use disorder

Stigma around substance use and mental health in rural communities is a significant barrier and an area where education and awareness are needed. To that end, the consortium has invited Tedra Cobb with University of Rochester (UR) Medicine's Recovery Center of Excellence to lead community conversations for two rural areas of the county (Darrington and Sky Valley) as well as a separate train-the-trainer event that will teach others in the community how to be facilitators of ongoing community conversations. These conversations focus on reducing stigma and increasing people's willingness to reach out and ask for help, seek treatment, or provide supports for those who are seeking treatment or are in recovery.

The Snohomish County Health Department is providing support for promotion and outreach. Our goals:

- Raise the profile of these events in communities where the series is happening and bring in guests from leading agencies in the opioid response throughout the county.
- Get people to be present and be seen having these conversations about stigma.
- Gain interest from a variety of partners in the train the trainer to establish an ongoing conversation in our community.
- Highlight the importance of continuing this work in our rural communities.







Join the conversation about substance use and stigma in rural communities

The Snohomish County Rural Opioid Response Project Consortium is hosting community conversations June 26 and 27 in Darrington and Monroe.

SNOHOMISH COUNTY, Wash. – Residents of rural communities are invited to be part of a community conversation about substance use disorder and stigma.

Free community events in Darrington and Monroe the last week of June will bring people together to talk. Topics include stigma in our communities, how we support people with substance use disorder and their families, and how to work together on reducing stigma. These interactive discussions will be facilitated by Tedra Cobb, a consultant with the University of Rochester Medicine Recovery Center of Excellence.

These events are hosted by the Snohomish County Rural Opioid Response Project Consortium. The consortium is a group of partners from organizations serving populations in Darrington and Sky Valley. The group came together in 2019 as part of a grant-funded effort by the Snohomish

County Health Department focused on reducing the impact of substance use disorder in rural communities, where access to services and recovery support often is more limited than in urban areas. Their work is supported by funding from the Rural Communities Opioid Response Program Planning grant from the Health Resources and Services Administration (HRSA) of the U.S. Department of Health and Human Services.

The consortium has identified priorities for Darrington and Sky Valley, including:

- early intervention and prevention
- reducing community impacts of substance use disorder
- increasing availability of treatment options
- eliminating barriers to treatment and support
- increasing education and awareness about substance use disorder

Stigma can be a tremendous barrier to treatment and support. Education and conversations can help reduce that barrier for those seeking help for themselves or a loved one.

"QUOTE"

Last year in Snohomish County, 270 people died of opioid-related overdoses, <u>according to preliminary 2023 data</u>. The majority of those deaths involved fentanyl. The number of fatal overdoses has increased alarmingly in recent years. This is a crisis that can impact anyone, regardless of age, gender, race, education, economic status, or where they live.

If you or someone you know is struggling with substance use disorder, help is available. It often takes more than one attempt to quit using, so don't give up. The Washington Recovery Help Line is staffed 24 hours a day, 7 days a week. Call or text: 1-866-789-1511.
